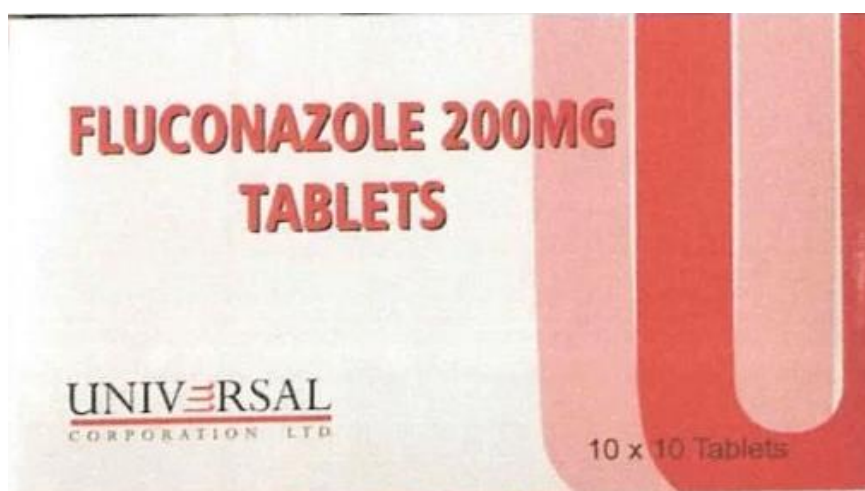
### **VOLUNTARY RECALL OF FLUCONAZOLE 200MG TABLETS MANUFACTURED BY UNIVERSAL CORPORATION KENYA LIMITED**

The COMESA Competition Commission (the Commission) has become aware through the media release dated 29 December 2023 by Rwanda Food and Drug Authority (FDA) that the agency had recalled **Fluconazole 200mg Tablets** manufactures by Universal Corporation Kenya Limited (UCL) following a voluntary recall by the manufacturer in its notification with reference no. UCL/PD/pp/2023/05/043 for discoloration of the tablets. The tablets were found to lose colour after a short shelf life.

In its media release, the Rwanda FDA instructed all importers, central medical stores, wholesale dealers, retailers, and all health facilities to stop the distribution of the drugs and return them to the suppliers. The Commission`s preliminary findings indicate that in the Common Market, UCL distributes its medicines in Burundi, DRC, Malawi, Rwanda, Somalia, Uganda and Zambia.
