## CONSUMER ALERT

## RECALL OF BENYLIN PAEDIATRIC COUGH SYRUP 100ML BATCH NO. 329304 MANUFACTURED BY JOHNSON & JOHNSON (PTY), SOUTH AFRICA

The COMESA Competition Commission (the Commission) has become aware through the public notice dated 12 April 2024 from the Zambia Medicines Regulatory Authority and from a public alert dated 11 April 2024 from the Kenya Pharmacy and Poisons Board alerting the general public of the recall of Benylin Paediatric Cough Syrup Batch No. 329304. Benylin Paediatric Syrup is used for the relief of cough and its congestive symptoms, fever and other allergic conditions in children aged 2 to 12 years. The recall has been necessitated by detection of high levels of Diethylene glycol following laboratory analysis. The product was first recalled by the Nigeria's National Agency for Food and Drug Administration and Control (NAFDAC) in its press release dated 10 April 2024 which can be accessed on the following link: <u>Public Alert No. 013/2024</u> -Alert on Recall of Benylin Paediatrics Syrup in Nigeria - NAFDAC.
