WARNING NOTICE TO THE GENERAL PUBLIC

RECALL OF BATCH NO. A4042 OF EFFERALGAN VITAMINE C 500mg/200mg (commprimé effeverscent) MANUFACTURED BY UPSA/SAS, FRANCE.

The COMESA Competition Commission (the Commission) has become aware of the recall notice by Rwanda Food and Drug Authority (Rwanda FDA), Ref. No. DD/PVCT/2986/FDA/2024 dated 30 June 2024, recalling EfferalganVitamine C 500mg/200mg (commprimé effeverscent), Batch No. A4042, manufactured by UPSA/SAS, France. The notice states that the product has been recalled due to colour changes from white to brown which compromises quality standards of the product.

The Rwanda FDA wrote to all stakeholders involved in the importation, distribution, prescription and consumer of the drug requesting:

- to stop distribution and dispensing of the recalled drug with immediate effect
- to report to the Rwanda FDA within 10 working days from the date of publication of this recall, the quantities imported/procured, quantities distributed, quantities returned and final stock at hand (returned +undistributed).
- anyone in possession of the recalled batch to stop using the medicine.

Preliminary investigations by the Commission have established that the recalled drug is also distributed in Burundi and the Democratic Republic of Congo. The Commission is therefore concerned that the recalled batch might have been imported in other COMESA Member States.

In this regard, pursuant to Article 30(1)(b) of the COMESA Competition Regulations, the Commission wishes to warn consumers in the Common Market of the risks associated with the recalled product as specified in the notice by Rwanda FDA.

The Commission also requests any person who establishes that the above recalled product, batch No. A4042, is being sold in other COMESA Member States to avoid its purchase or use, and report the matter to the Commission by contacting **Mr. Steven Kamukama, Director Consumer Welfare and Advocacy Division** on +265 (0) 111 772466 or by email on: skamukama@comesacompetition.org
