

COMMITMENTS IN RESPECT OF MERGER

IN THE MATTER OF: Merger Filing between ETG Inputs HoldCo Ltd (Acquirer) and Klein Karoo Seed Marketing Zimbabwe (Private) Limited, Agriculture Seeds and Service (Private) Limited and Klein Karoo Seed Zambia Limited (Target Companies).

We, NIRENMURUGAN, COO(EIHL) & JAMES GLENN, being authorized representatives of ETG Inputs HoldCo Ltd (ETG), Klein Karoo Seed Marketing Zimbabwe (Private) Limited and Agriculture Seeds and Service (Private) Limited acting for and on behalf of the aforementioned parties, do hereby make the following commitments to the COMESA Competition and Consumer Commission:

1. ETG Inputs HoldCo Ltd, its subsidiaries, branches, affiliates, successors in title or other entities directly or indirectly controlled by them, undertakes to supply fertiliser inputs to third party customers in the Republic of Zimbabwe on a fair, reasonable, and non-discriminatory basis, ensuring that the conditions granted to the third party customers are no less favourable, for comparable situations, than those granted to ETG Inputs HoldCo Ltd for its business of blended fertilisers in the Republic of Zimbabwe;
2. The merged entity shall not engage in any conduct that relates to tying or bundling in relation to the supply of its seeds, fertilisers and agro-chemicals that will have the specific object or effect of significantly preventing or lessening competition in the Republic of Zimbabwe;
3. The merged entity shall continue the performance of existing contracts for the supply of seeds to customers of Agriculture Seeds and Service (Private) Limited and Klein Karoo Seed Marketing Zimbabwe (Private) Limited on a fair, reasonable, and non-discriminatory basis in the Republic of Zimbabwe. The merged entity commits that the supply of seeds to the existing customers of Agriculture Seeds and Service (Private) Limited and Klein Karoo Seed Marketing Zimbabwe (Private) Limited shall not cease as a result of the transaction in the Republic of Zimbabwe;
4. The distribution contracts between the merged entity and the distributors of Agriculture Seeds and Service (Private) Limited and Klein Karoo Seed Marketing Zimbabwe (Private) Limited shall not be terminated by virtue of the merger. Such contracts may be terminated on account of breach of contract, poor performance, expiration of the contract, among other things;
5. The merged entity shall maintain the brands of Agriculture Seeds and Service (Private) Limited and Klein Karoo Seed Marketing Zimbabwe (Private) Limited as separate seeds brands and shall not consolidate the latter brands into a single brand identity in the Republic of Zimbabwe;
6. The above commitments shall remain in force for a period 3 years from the date of the implementation of the transaction;
7. The parties commit to submit, within thirty (30) days of each anniversary of the Implementation Date, for the next three (3) years, a comprehensive report detailing compliance with these commitments. The submission of the latter report does not, however, stop the Commission from undertaking periodic reviews of the markets to assess compliance; and



8. We acknowledge that these commitments are made with full knowledge that it may be relied upon by the Commission in its regulatory proceedings and decision-making processes.

THEREFORE, we respectfully submit these commitments in compliance with the Commission's requirements and for the purposes of completing the merger approval process.
